# 1. MEETING CALLED TO ORDER & PLEDGE OF ALLEGIANCE

The Regular Board of Education Meeting was held at the Jr./Sr. High School in the library. The meeting was called to order by Board President Wood at 7:01 p.m. and opened with the Pledge of Allegiance.

#### 2. PUBLIC HEARING

Board President Wood opened the public hearing regarding the Low Income Senior Exemption (Real Property Tax Law 467) at 7:01 p.m. Michael Los, Business Administrator updated the Board regarding the Low Income Senior Exemption. The exemption remains in place until the Board passes a new resolution to override it. The resolution does not have to be voted on annually. A new resolution is only needed if there is a change. The only time a senior citizen is not eligible for the exemption is if the child is living in the house for the sole purpose of attending New Lebanon. Currently, there are two households in our District that would benefit from this exemption.

Board President Wood made the motion to close the hearing at 7:09 p.m. Board Member Bienes seconded the motion. Motion carried. 5 ayes, 0 nays, 0 abstained.

# 4. ACKNOWLEDGEMENTS/ADMINISTRATIVE COMMENTS

Jill Risko, Student Representative, reported to the Board. Students are excited about the end-of-the-year fundraiser. Shamrocks are being sold by Student Council. All proceeds go to Muscular Dystrophy. Jill also reported that the student body is excited about the new vending machines that are in the cafeteria.

Michael Los, Business Administrator, updated the board of the impact of sequestration on 611/619 and Title grants and recalculations of building aid impact.

Mary Mabb, Transportation Supervisor, and Bill Lyons from New York State Bus Sales spoke about propane buses. Discussion will continue.

Becky Marzeski, WBH Elementary Principal, congratulated Aiden Hoogs, second grader in Miss Griffin's class, for the story he wrote, "Alien Revengers." His story was uploaded to the video page of Green Screen Adventures' website. It will premiere on Me TV, Sunday, April 7th at 8 a.m. It will also run on THIStv, Saturday, September 14th at 10 a.m. Additionally, it will be showcased at tomorrow's Tiger Jam Assembly.

Becky also updated the board that the Dental Van was at WBH from February 4th – 15th. This service benefitted 30 of our students. If the child's family had insurance, the insurance company was billed. If a child's family had no insurance, they received free dental care.

Becky informed the board that next week is Spirit Week. As part of the various spirit activities, our PTA is sponsoring a special songwriting and spirit assembly for our school. Jeff Blum will guide the students to write a school song. The song will be recorded on CD's and given to our students.

Becky also updated the board about Family Literacy Night "Bear Snores On." On Wednesday, March 6th at 6:00 PM, the PTA will be sponsoring a Family Literacy Night for pre-k – first students and their families. Families will watch a story called, "Bear Snores On" on WMHT Public Television.

Leslie Whitcomb, Jr./Sr. High School Principal, updated the Board about the Guidance department's FAFSA night. Letters have gone out for individual student scheduling meetings. Parents were invited to participate. Through Distance Learning, students will participate in an anti-cyber bullying virtual field trip "Wired and Routed." Our SADD club will participate in a three-day program sponsored by the Anti-Defamation League. The program will teach awareness, ally training and presentation skills. Home & Careers has a field trip coming up. Drama Club will perform a play on March 15. Family Fun Night is this Friday. The variety show is scheduled for March 21.

Matt Klafehn, Athletic Director/Assistant Principal, reported that the Girls Varsity Basketball Team and Boys Varsity Volleyball seasons came to a close with first round losses in Sectional play against Hartford and Chatham

respectively. The Winter Athletic Awards banquet was held on Tuesday to honor our student athletes. The dinner was sponsored by the class of 2015 along with the cheerleading squad. Spring Sports practices begin on Monday and a "Meet the Coaches" night is scheduled for Tuesday evening. Both our students and their coaches are anxious for the season to start.

Superintendent McGraw gave an update to the board on a proposed primary configuration for the 2013-2014 school year.
