#### 1. MEETING CALLED TO ORDER & PLEDGE OF ALLEGIANCE

The Regular Board of Education Meeting was held at the Jr/Sr High School in the library. The meeting was called to order by Board President Lambert at 7:00pm and opened with the Pledge of Allegiance.

Frank Healy shared that the elementary swim program is a success using level six swimming students with lower level swimming students to help them improve.

#### 3. ACKNOWLEDGEMENTS/ADMINISTRATIVE COMMENTS

A. Student Representative update: Usman Sadiq was not present.

- B. The Business Office/Facilities and Grounds update was presented by Michael Los. Bids were opened for the bus garage renovation. The overall bids came in under projections. Since the Capital Reserve fund was established for the bus garage project, this should leave additional funds that could be used to address other facility needs.
- C. The Walter B. Howard update was given by Leslie Whitcomb. Teachers will spend the afternoon on Friday, January 24<sup>th</sup> assessing student progress now that they have reached the mid-year point. A writing curriculum for grades 5 & 6 is being developed. The safety committee met to review recommendations from the Questar audit. WBH is experiencing high absences due to colds and strep throat. Permission slips will go home on Friday, January 24<sup>th</sup> for movie night. Students will select their movies during classes next week. In addition to the familiar groups such as the environmental club and Drama, Miss Boyce, new music teacher, has formed a show choir. These students meet regularly to prepare performance pieces for both the spring concert and for the talent show in the spring. The WBH library is being prepared for renovation. Some shelves and cabinets have

been removed for new fixtures. Applications are currently being reviewed for the new elementary principal. The faculty interview team is in place.

D. Jr/Sr High School update presented by Matthew Klafehn. Dolores Storey's graphing calculators class orchestrated a bungee jump for a Barbie doll. Students had to formulate a conjecture, stating the maximum number of rubber bands that they believed would allow Barbie to safely jump from a height of 400 cm. Josie Bartholomew, a New Lebanon senior attending Tech Valley High School, started clinical rounds in Troy's Van Rensselaer Manor as she advances towards a CNA (Certified Nurses' Assistant) certification with Questar III. Arianna Burns, a New Lebanon freshman attending Tech Valley High School, went to Haiti the week of January 7<sup>th</sup> along with a select group of students where they taught farmers how to build solar powered dehydrators and take an inventory of mango trees in the area of Comier, Haiti. Kara Siciliano was selected as News channel 13 Teacher of the Week. Elaine Houston and film crews will be on campus on February 26th to see Kara in action. Corie Noel, math teacher, was selected as a panelist to serve on a New York State Education Department Algebra I Common Core Performance level Descriptor Committee. Jennifer Allard, Social Studies teacher, has been selected to attend a conference at American Federation of Teachers headquarters in Washington DC for the purposes of assisting in the development of Social Studies resources aligned to the Common Core learning standards.

Motion for the State Environmental Quality Review Act (SEQRA) WHEREAS, the Board of Education of the New Lebanon Central School District ("Board") has proposed to undertake a project consisting of replacing portions of the roof at the Jr/Sr High School ("the Project"); and WHEREAS, the Board wishes to fully comply with its obligations under the State Environmental Quality Review Act ("SEQRA") and the regulations there under with respect to the proposed action; and WHEREAS, the Board has carefully considered the nature and scope of the proposed action; and WHEREAS, upon review of the foregoing, the Board makes the following determinations: 1. The proposed action involves replacing portions of the roof at the Ir/Sr High School ("The Project"); 2. The proposed project represents maintenance or repair involving no substantial changes in an existing facility or structure within the meaning of 6 NYCRR 617.5(c)(1); and/or alternatively the replacement, rehabilitation or reconstruction of a structure or facility in kind within the meaning of 6 NYCRR617.5(c)(2); and/or alternatively a routine activity of an educational institution within the meaning of NYCRR § 617.5(c)(8). 3. The proposed action will in no case have a significant adverse impact based on the environment based on the criteria contained in 6 NYCRR. § 617.7(c), and is not otherwise a Type I action as defined by 6 NYCRR § 617.4. 4. The proposed action is a Type II action within the meaning of 6 NYCRR 617.5 and is therefore not subject to review under SEQRA and the regulations there under. NOW THEREFORE BE IT RESOLVED that the Board finds and concludes that the proposed action is a Type II action within the meaning of 6 NYCRR 617.5 and therefore is not subject to review under SEQRA and the regulations there under.

WHEREAS, the architect has recommended the award of the contract to the above contractor. THEREFORE: BE IT FURTHER RESOLVED that the general contract work for renovations at the bus garage is awarded to Hoosick Valley Contractors, Inc. with a base bid of \$496,457 and a GC-2 add alternate bid of \$10,500 resulting in a net contract award of \$506,957.
- K. Motion to award Mazone Plumbing and Heating the mechanical work bid for renovations at the bus garage. WHEREAS, the New Lebanon Central School District received, accepted and opened bids for mechanical work for renovations at the bus garage on January 16, 2014; and WHEREAS, the lowest responsible bidder was Mazone Plumbing and Heating. WHEREAS, the architect has recommended the award of the contract to the above contractor. THEREFORE: BE IT FURTHER RESOLVED that the mechanical work for renovations at the bus garage is awarded to Mazone Plumbing and Heating, with a base bid of \$95,855 resulting in a net contract award of \$95,855.
- L. Motion to award Mazone Plumbing & Heating the plumbing bid for renovations at the bus garage. WHEREAS, the New Lebanon Central School District received, accepted and opened bids for the plumbing renovations at the bus garage on January 16, 2014; and WHEREAS, the lowest responsible bidder was Mazone Plumbing & Heating. WHEREAS, the architect has recommended the award of the contract to the above contractor. THEREFORE: BE IT FURTHER RESOLVED that the plumbing bid for renovations at the bus garage is awarded to Mazone Plumbing & Heating, with a base bid of \$49,164 resulting in a net contract award of \$49,164.
- M. Motion to award Stilsing Eclectric the electrical bid for renovations at the bus garage.

WHEREAS, the New Lebanon Central School District received, accepted and opened bids for electrical work for renovations at the bus garage on January 16, 2014; and WHEREAS, the lowest responsible bidder was Stilsing Electric. WHEREAS, the architect has recommended the award of the contract to the above contractor. THEREFORE: BE IT FURTHER RESOLVED that the electric work for renovations at the bus garage is awarded to Stilsing Electric with a base bid of \$33,660, an EC-2 add alternate bid of \$3,977, and an EC-3 add alternate bid of \$22,318 resulting in a net contract award of \$59,955.
