Public Hearing at 7:00 p.m. Regular Meeting at 7:30 p.m. January 6, 2010

The regular meeting was held at the Jr./Sr. High School. The meeting was called to order by Board President Wood at 7:04 p.m.and opened with the Pledge of Allegiance. The public hearing started at 7:05 p.m.

Public Hearing

A public hearing was held regarding the Union Free School Building. The building history was reviewed. Options were discussed. Sharon Kugler spoke on behalf of the Historical Society. Nancy Clement spoke about the historical value of the building and its placement on the National Historic Register. Funding possibilities were reviewed and that at this time there are no grants or State Aid available. Restrictions on selling the property were reviewed. It was noted that asbestos removal in 2006 makes future use of the building or demolition more feasible.

Students, Meredith Lucas and Tracey Wellington will have their work displayed in the Columbia Greene art gallery. Regents exams are at the end of January. The December music concert and art show featured the choir and included student instrumentals and the band included vocals. A lockdown drill was conducted in December.

Non-Action Items

Superintendent McGraw reviewed several items with the Board. A two-bell vs. one bell memo. This will be discussed further at a future meeting. Ms. Sue Wilkes asked about appointing a Varsity Softball coach.
