A. Motion to abolish positions

To abolish positions:Elementary Teachers

RESOLVED, that two (2) 1.0 FTE teaching positions in the tenure area of elementary are hereby abolished, effective June 30, 2025; and it is further,

RESOLVED, that the two (2) most junior incumbents in the elementary tenure area shall be laid off effective June 30, 2025, and placed on a preferred eligible list for recall to a vacant or newly created similar position, for up to seven (7) years.

B. Motion to abolish a position

Reading Teacher

RESOLVED, that a 1.0 FTE teaching position in the tenure area of literacy and reading is hereby abolished, effective June 30, 2025; and it is further,

RESOLVED, that the most junior incumbent in the literacy and reading tenure area shall be laid off effective June 30, 2025, and placed on a preferred eligible list for recall to a vacant or newly created similar position, for up to seven (7) years.

C. Motion to abolish a position

Physical Education Teacher

RESOLVED, that a 1.0 FTE teaching position in the tenure area of physical education is hereby abolished, effective June 30, 2025; and it is further,

RESOLVED, that the most junior incumbent in the physical education tenure area shall be laid off effective June 30, 2025, and placed on a preferred eligible list for recall to a vacant or newly created similar position, for up to seven (7) years.
