
Preserves programs, keeps tax levy increase at 0% for seventh consecutive year

On Tuesday, May 21 the New Lebanon Community will vote on a \$12,480,879 proposed budget for the 2019-20 school year.

The plan represents a decrease in spending over the current year's budget. In addition to staying below the calculated tax levy limit, the proposed budget represents a 0% tax levy increase for the seventh consecutive year. This year, as in years past, the district has budgeted well below their allowable tax levy limit of 4.17%. The district has been able to keep the levy increase at zero because of long-term financial planning and ongoing evaluation of all programs for efficiencies and cost savings.

"The proposed budget preserves all existing programs, which contribute to maintaining the quality education we aim to provide all of our students from pre-kindergarten through high school, while being mindful of the financial impact on our taxpayers," said Superintendent Leslie Whitcomb.

This budget funds the addition of one elementary teacher position, needed due to increased enrollment. The proposed budget will continue to fund the services and programs that the community has come to expect from a New Lebanon education: a half-day Pre-K program, small class sizes, clubs, sports, recreational opportunities, and individual planning for higher education and careers. The budget supports our comprehensive program including extensive electives: computer science, art, music and health courses beginning at the elementary level and continuing through grade 12. The budget also provides for college credit courses in math, science, social studies, art, business, English and technology.

Some NLHS athletic teams merge with Berlin High School

This spring, the New Lebanon Board of Education approved the merger of the track teams as well as JV and Varsity baseball, softball and basketball teams with Berlin High School.

Declining participation rates at both schools has made it difficult to field teams. Beginning this spring, the combined teams will compete in the Wasaren League which Berlin joined two years ago. The merger will strengthen the teams' ability to compete.

"Athletics is a key component to the educational program; by merging, we are ensuring that the quality of play remains high while continuing to give those opportunities to kids that otherwise might not have had the opportunity to play," said Superintendent Leslie Whitcomb.


Another added benefit, says Whitcomb, is the social aspect. The combining of the teams gives student athletes a chance to make friends outside of their normal school circles.




